Our website uses different types of cookies. This Cookies Notice explains what cookies we use, how we use them, and how you can manage your preferences.

### 1. What are cookies?

When you visit a website, the website requests your browser to store a cookie on your computer or mobile device. A cookie is a small piece of data (text file) generated by a website that remembers information about you and your website usage.

Cookies allow us to recognize your device, store information about your preferences, and help provide a functioning website.

Some cookies are placed by third-party services that appear on our pages and help us provide you with a better usage experience.

### 2. What cookies do we use?

As we mentioned, our website uses different types of cookies. Namely, we use necessary and analytics cookies.

#### 2.1. Necessary cookies

Necessary cookies are required to enable the basic features of our website, such as logging into your account. These cookies may store personally identifiable data, which we process in accordance with our [Privacy Notice](#).

We use the following necessary cookies:

Name	Purpose	Expires
__Secure-better-auth.session_token	This cookie is used to maintain the user's authenticated session after logging in. It ensures that the user remains securely logged in while navigating between pages.	7 days
__Secure-better-auth.session_data	Stores data required to authenticate the user and maintain their logged-in session.	5 minutes

#### 2.2. Analytics cookies

Analytics cookies collect information about how you use this website and help us improve performance and provide a better user experience. We use PostHog for this purpose. Cookies of this type collect information about the pages you visit and if you experience any errors.

The table below aims to explain the type and purpose of the cookies used.

ph_phc_1BjzD77h9lhukgn IRqKh895ECgy7UBEuKe BvTAsFzxo_posthog	Used to collect statistical data about user interactions with the website via PostHog (an analytics platform). This helps improve website functionality by understanding user behavior.	7 days
